Information to Exhibitors:

- In the event of a tie between classes, the tie shall be broken in favor of the dog entered in the higher class. In the event of a tie within a class, the tie shall be broken in HTD classes with the best fetch score, followed by best pen score, then time. In HTAD classes, the tie will be broken with the best gather score, followed by best repen score, then time.
- This event is open to all dogs nine months of age or older.
- Bitches in heat participate in running order.
- Dogs must be sound and in good health.
- Owners of participating dogs need not be a member of any club or organization.
- A dog owned or co-owned by the judge or any member of the judge's immediate family or household may not be evaluated by the judge, nor may a judge evaluate a dog of which that judge has been owner, co-owner or primary trainer/handler within the last six months.
- Non-Competitive runs and/or Exhibition Only runs are allowed. A Non-Competitive run is run solely for earning a leg and is not eligible for prizes and ribbons. Exhibition Only runs are handled similarly except that no leg is being sought and is not eligible for prizes and ribbons.
